You may water on your watering day between the hours of 12:01 am to 8:00 am or between the hours of 6:00 pm and 11:59 pm. You may only water once on your approved day.

Reclaimed Water Customers

You may water from 12:01 a.m. to 8:00 a.m. **OR** 6:00p.m. to 11:59 p.m. on your designated reclaimed water irrigation days.

Your reclaimed water irrigation days are as follows, based upon the LAST NUMBER of your address:

0 or 1	Tuesday and Friday
2 or 3	Thursday and Sunday
4 or 5	Monday and Friday
6 or 7	Tuesday and Saturday
8 or 9	Wednesday and Sunday

New Website for Pasco County Sheriff

Pasco Sheriff Bob White is pleased to announce the unveiling of the agency's new website that features many customer-oriented interactive links to provide citizens with more information than ever before.

Some of the new links on the website include:

- Active calls log: Details calls for service that are currently coming into the Sheriff's Office communications Unit, including call number; the time the incident was reported; the type of call; the response priority assigned to the call; and the general location of the call;
- Dispatch log: A comprehensive list of calls for service and offense reports, updated nightly, and includes the last 30 days activity;
- Subdivision activity log: Like the dispatch log listed above, but narrowed down to specific subdivisions. This information is also updated nightly, and includes the last 30 days activity;
- Inmates in jail: A log of arrest and booking information, to include photos of arrestees;
- Outstanding warrants: A link to an outstanding warrants database.

Eventually, citizens will also be able to:

Use a sexual predator and offender database to map where these individuals live in the county and be notified if one moves into or out of their neighborhood;

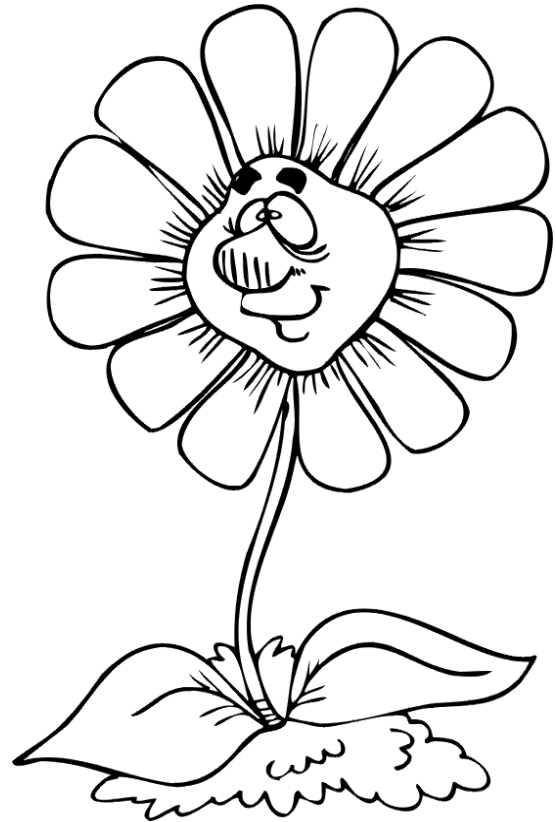
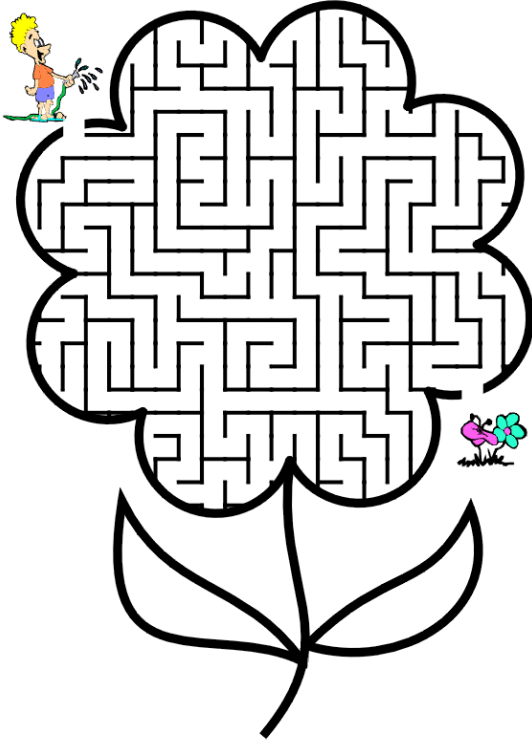
Sign up for Sheriff's monthly email newsletter and other important communications. The website will continue to feature information that citizens are familiar with, such as unsolved cases, job and volunteer opportunities, crime prevention tips, and current news and events. The website was redesigned over the past year by the agency's Information Technology section, which provides and services the computing and telecommunications infrastructure of the Sheriff's Office 24 hours day.
