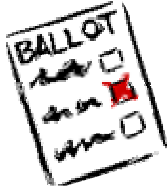

1. Recycle used milk jugs - wash and cut off the top portion of the milk jug
2. Fill milk jug 1" to 1-1/2" with either dirt, sand or kitty litter.
3. place one emergency candle (available at any Dollar Store 8-10 per box) firmly inside the milk jug.



Place on sidewalks approximately 2-3 feet apart and light candle in the late evening. should remain lit all through the night.
